## **General unrestricted bequest**

# Specific or designated bequest

"My estate trustees shall pay Rockway Mennonite Collegiate Inc. X# shares of ABC stock...for its general purposes as its Board of Directors may determine for fulfilling its mission."

#### OR

"My estate trustees shall pay Rockway Mennonite Collegiate Inc. the sum of \$\_\_\_\_\_ to be used to benefit Rockway Mennonite Collegiate Inc., Name of Fund; if the fund no longer exists for Rockway Mennonite Collegiate Inc., the sum of aforementioned will be designated to its general purposes as its Board of Directors may determine for fulfilling its mission."

#### OR

"My estate trustees shall pay Rockway Mennonite Collegiate Inc. the sum of \$\_\_\_\_\_\_ to be used to benefit Rockway Mennonite Collegiate Inc., The General Endowment Fund; if the fund no longer exists for Rockway Mennonite Collegiate Inc., the sum of aforementioned will be designated to its general purposes as its Board of Directors may determine for fulfilling its mission."

## **Residual bequest**

"My estate trustees shall pay \_\_\_\_\_% of the residue of my estate to Rockway Mennonite Collegiate Inc., to be used for its general purposes as its Board of Directors may determine for fulfilling its mission."

## **Contingent bequest**
